Personal data that we process

Toskr processes your personal data when you make use of our services and/or when you provide these to us yourself. Below you will find an overview of the personal data that we process:

Special and/or sensitive personal data that we process

Our website and/or service has no intention of collecting data about website visitors who are younger than 16 years of age, unless they have permission from their parents or guardian. For what purpose do we process personal data?

Sharing of personal data with third parties

Cookies

A cookie is a small text file that is stored on your computer, tablet or smartphone when you first visit this website. They also enable us to optimise

Reviewing, modifying or deleting data

This is to protect your privacy. We will respond to your request as soon as possible, but within four weeks.
